## USE MULTIPLE ESTABLISHED U.S.-BASED EXCHANGES



#### Advantages

- Diversifies counterparty risk, known bankruptcy workout procedures.
- FDIC insurance offered on USD balances (Up to \$250k)
- Available Customer Service
- Less foreign legislation risk

#### Disadvantage

- More cumbersome application process
- Not all cryptocurrencies will be available on U.S. based exchanges.
- 1099 Tax Reporting

- Initial Coin Offerings (ICOs) (were) ripe for fraud.
- To reduce the risk of investing in a fraudulent project or one that will be targeted by the SEC ...

#### We Require

- More Be Listed on a Registered US Based Exchange
- Have a \$1 Billion dollar market capitalization
- Not be a "Privacy Coin"
- Not have been ICOed in the second half of 2017 in the USA

#### **Electronic Vaulting - Sterile Devices - Two Factor**

Establish Sanitized Devices

Specifically for Accessing

Cryptocurrency Accounts and establish 2-factor authentication, utilizing "non-sim card based" 2 factor protocol.

Move long term eligible holdings into "time delayed" Digital Vaults.

Avoids exposing your device to malicious software, viruses, or other phishing programs.
