ABOUT THE DECENTRALIZED AI STRATEGY

Decentralized AI, LP seeks to maximize investment returns by allocating capital to AI focused blockchain-based projects that enable decentralized AI adoption. Sarson Funds investment team is collaborating with Manifest AI and the Manifest Network to identify and opportunistically allocate capital to early stage and established projects that empower, utilize, distribute, support, develop or design AI related projects, and projects focused on delivering, enhancing or improving decentralized access to AI, AI training, computing power, storage and Large Language Models. In normal conditions, the Partnership will invest 50% or more of its capital in the liquid tokens of qualifying established decentralized AI projects and up to 50% of its capital in non-tradable early stage investments.


SECURITY


